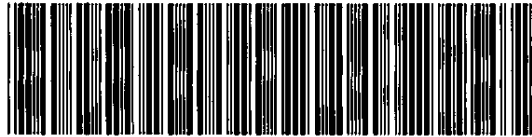

FIFTH: All debts, obligations, and liabilities of the LLC have been paid or discharged, or adequate provision has been made therefor pursuant to Section 608.4421.


SIXTH: All remaining property and assets by the LLC have been distributed among its members in accordance with their respective rights and interests.




