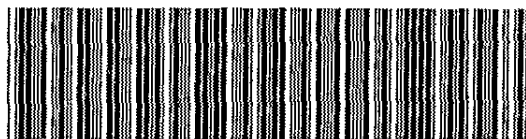

**ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge and file the following Articles of Organization.

**ARTICLE I**  
**NAME**

The name of the limited liability company shall be Marksman Security Schools, LLC (the "Company"). The principal place of business and mailing address of the Company in Florida shall be 2201 N.E. 52nd Street, Suite 203, Lighthouse Point, Florida 33064.
