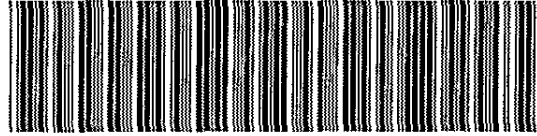



ARTICLE I – Name
