The Company is to be managed by a Manager, namely:

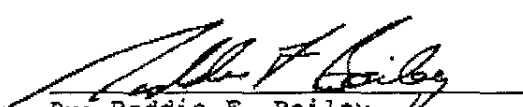

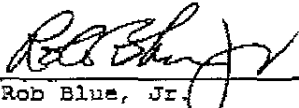
