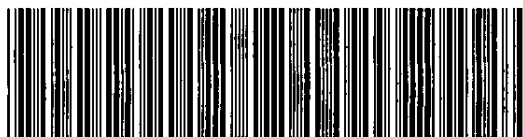

**ARTICLE IV - DISTRIBUTION**

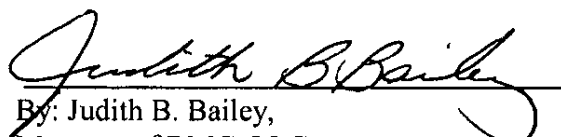
All remaining property and assets of the company have been or are will be distributed to the sole member.
