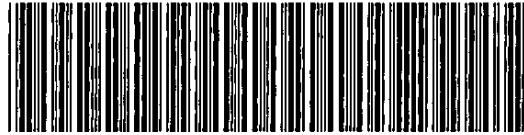

Therefore, **membership in NEW LIFE GROUP, LLC** is as follows:

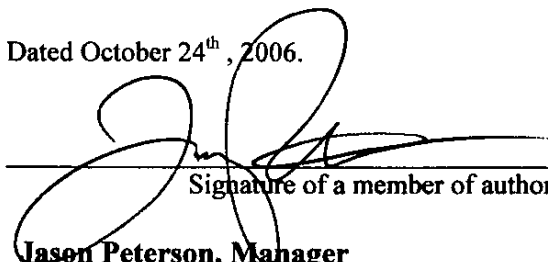
