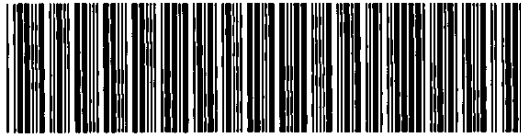

(Initial Managers)




