

**ARTICLES OF ORGANIZATION OF
FLIGHT CRAFTERS ENGINEERING, LLC**

Article I

The name of the limited liability company ("Company") is FLIGHT CRAFTERS ENGINEERING, LLC.

Article II

The mailing and street address of the Company's principal office is 400 Nut Tree Drive, DeLand, FL 32724. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.

Article III

The period of duration for the Company is perpetual.
