Article III

PURPOSE

This is a non-profit, educational organization whose mission is to foster the physical, mental, and emotional growth and development of Cape Coral's people through the sport of soccer. Our goal is to provide a safe, structured, and fair environment in which players can have fun playing, learning the game of soccer, combating community deterioration, and juvenile delinquency. We also hope to nurture and develop a lifelong passion for the sport as well.

Article VII

DISSOLUTION

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
