ARTICLE I

ARTICLE V

**REGISTERED OFFICE AND AGENT**

The name and street address of the registered agent of the Company in the State of Florida is Michael E. Dean, 230 N.E. 25<sup>th</sup> Avenue, Suite 100, Ocala, Florida 34470.

ARTICLE VI

**CAPITAL CONTRIBUTIONS**

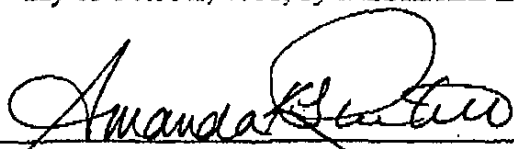
