**ARTICLES OF ORGANIZATION
OF
MLG PARTNERS, LLC**

The undersigned hereby adopt these Articles of Organization in order to form a limited liability company under Chapter 608, Florida Statutes.

**ARTICLE I
NAME**

The name of this limited liability company is *MLG Partners, LLC* (the "Company").

**ARTICLE II
DURATION**

The Company shall commence upon the filing of these Articles of Organization and shall exist perpetually thereafter.

**ARTICLE III
PURPOSE**

The purpose of the Company is to engage in any lawful business activity that is not prohibited with respect to a limited liability company organized according to the laws of the State of Florida.

**ARTICLE IV
ADDRESS**

**ARTICLE V

**ARTICLE VII
MEMBER'S RIGHTS TO CONTINUE BUSINESS**

The remaining Member(s) of the Company may continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company upon agreement as provided in the Operation Agreement of the Company.

**ARTICLE VIII
MANAGEMENT**

The Company shall be managed one or more of its Members or by one or more Non-Member managers, or by a combination of both, as provided for in the Operating Agreement of the Company.

**ARTICLE IX
ADOPTION OF OPERATING AGREEMENT**

The Members of the Company shall adopt the Operating Agreement which shall contain provisions for the management of the business and the regulation of the affairs of the Company that are not inconsistent with the Articles or the laws of the State of Florida.

**ARTICLE X:
AMENDMENT**

The Company shall have the power to amend or supplement these Articles of Organization when approved by the unanimous vote of the Members.
