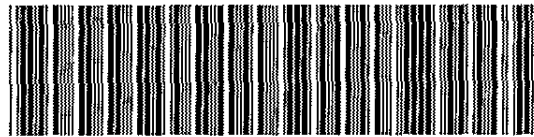

**ARTICLES OF ORGANIZATION
FOR
MSR P.O.S., LLC**

A Florida Limited Liability Company
