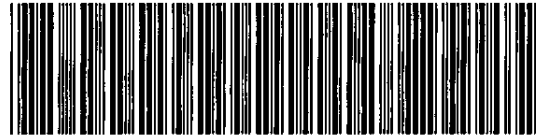

**ARTICLES OF ORGANIZATION  
OF  
AERONAUTICAL RESTORATION & MAINTENANCE FACILITY, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledge, and file the following Articles of Organization.

**ARTICLE I - NAME**

**ARTICLE II - ADDRESS**

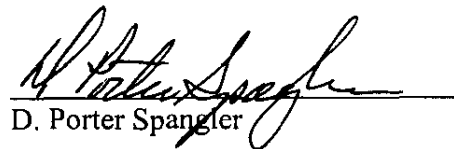
