

Pursuant to the provisions in Section 608.411 of the Florida Statutes, the undersigned limited liability company hereby adopts the following Articles of Amendment to its Articles of Organization pursuant to the unanimous consent of its members:

1. The Articles of Organization shall be amended to read as follows:

**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION OF

The undersigned member adopts the following Amended Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act and the provisions of the Professional Services Corporation and Limited Liability Company Act.

**ARTICLE I  
NAME OF COMPANY**

The name of the limited liability company is Trent Snider & Company, P.L. (the "Company").

**ARTICLE II  
PERIOD OF DURATION**

The Company shall terminate on October 23, 2106.



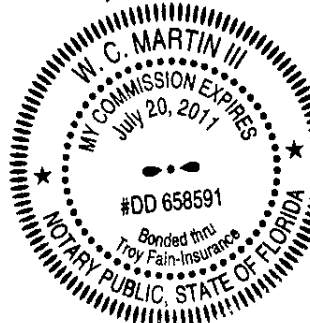


