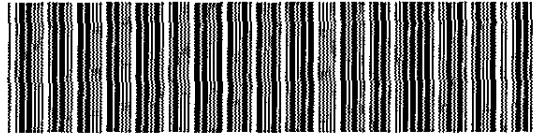

#### **ARTICLE V BUSINESS PURPOSE OF COMPANY**

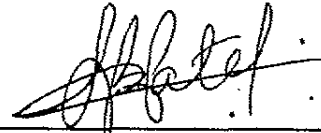
The primary business purpose of this Company shall be to invest in real estate development projects, as well as for any other purposes permitted by Florida law.
