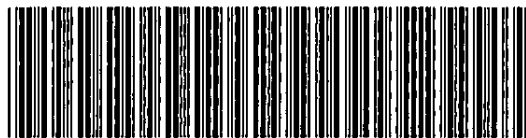



### CHANGE OF REGISTERED AGENT OF AP Imaging, LLC


