**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
BAYROCK RINGLING, LLC**

The undersigned, acting as the Manager of BAYROCK RINGLING, LLC, hereby adopts the following Amended and Restated Articles of Organization pursuant to §608.411 of the Florida Limited Liability Company Act, Chapter 608, Florida Statutes ("Act"), for the purpose of amending and restating the Articles of Organization of the company filed with the Florida Department of State on October 23, 2006.

ARTICLE I - NAME

The name of this limited liability company is: "BAYROCK RINGLING, LLC."

ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE

The existence of the company commenced on October 23, 2006, and the existence of the company shall be perpetual.

ARTICLE III - PURPOSE

The company may transact any or all lawful business for which a limited liability company may be organized under the Florida Limited Liability Company Act.

ARTICLE IV - INITIAL REGISTERED AGENT AND OFFICE

ARTICLE V - PLACE OF BUSINESS

ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

The right of the members to admit additional members and the terms and conditions of the admissions shall be restricted solely to those members approved by the written consent of all of the manager and upon such terms and conditions as shall be set forth in its regulations.

ARTICLE VII - MANAGEMENT BY MANAGER

The business of the company shall be managed by one or more managers in accordance with the terms and conditions set forth in the company's regulations and the name and address of the current manager of the company shall be as follows:

The power to adopt, alter, amend, or repeal the regulations of the company is vested exclusively in the members of the company.

ARTICLE X - TERMINATION OF A MEMBERSHIP INTEREST

The company shall not be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the company.

ARTICLE XI - AMENDMENT OF ARTICLES OF ORGANIZATION

Any amendment to the Articles of Organization shall be approved by all of the members and shall be as prescribed by the Secretary of State of the State of Florida.
