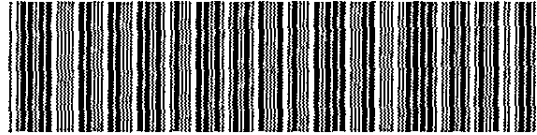


## ARTICLE IX – CONTINUATION

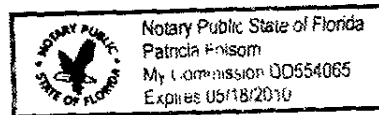
