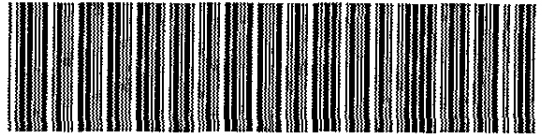



**ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be: SALIENT MOTORCARS, LLC.

**ARTICLE II -- ADDRESS**

The street address of the principal office and mailing address of this company is 837 Woodward Street, Lakeland, Florida 33803.

**ARTICLE III -- DURATION**


