

Pursuant to the provisions of the Florida General Corporation Act, the undersigned limited liability company adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is SCOTT'S LANDING, LLC., filed on October 23, 2006, document number L06000103348.
2. The following amendment of the Articles of Organization was adopted by the unit holders and managing member of the limited liability company on the 6<sup>th</sup> day of December, 2006, in the manner prescribed by the Florida General Corporation Act:

"ARTICLE V. MANAGEMENT" is hereby deleted in its entirety and substituted therefore is the following:
