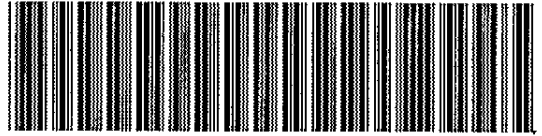

Name

No person may be admitted as an additional member without the unanimous consent of the members. If such person is admitted, he or she shall be subject to the obligations and limitations in

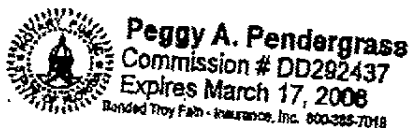
the Regulations and Operating Agreement of the limited liability company, as amended for the additional members.


