#### ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized member, desiring to form a limited liability company under the Florida Limited Liability Company Act, Chapter 608. Florida Statutes, exces hereby adopt the following Articles of Organization:

#### ARTICLE I: NAME

The name of the limited liability company is CPES, LLC (the "Company").
