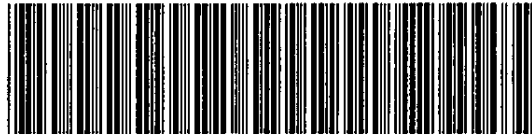

The name of this limited liability company shall be: **MONTEGO SAVANNAH INVESTMENTS GP, LLC.**


ARTICLE II


