PLAN OF MERGER

This Plan of Merger (the "Plan") is adopted as of December 10, 2007 by TITUSVILLE INVESTMENT GROUP, I.I.C. a Florida limited liability company ("TIG") and DBSI-TIG TITUSVILLE, LLC, a Florida limited liability company ("DBSI").

RECITALS
