**ARTICLE VII- Limitation on Agency Authority of Members:**

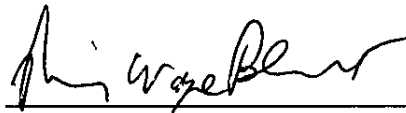

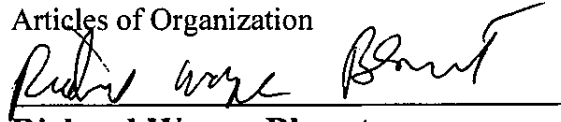

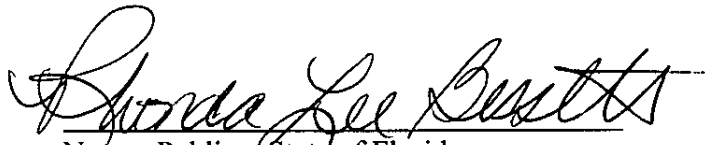
