to the
ARTICLES OF ORGANIZATION

WHEREAS, GTVR IMAGING, LLC. ("Company") is a Florida limited liability company, validly formed by filing its Articles of Organization on October 26, 2006, and assigned document number L06000104437; and

1. Article I- Name:

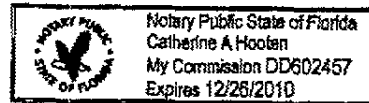
