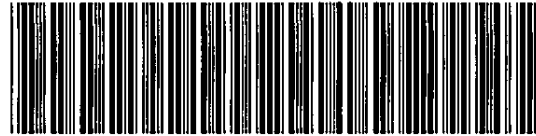




1. The name of the limited liability company is: Southpointe Properties, LLC.


