

**PLAN OF MERGER

(1) The name and jurisdiction of the surviving entity are Masonic Lodge, LLC, a Florida limited liability company.

(2) The name and jurisdiction of the only merging entity are: Only T, LLC, a Florida limited liability company.

(3) The only condition of the merger is the merging parties' compliance with the provisions of chapter 605, Florida Statutes; the terms of the merger are described in section 605.1026, Florida Statutes.
