The existence of the Company shall begin on October 27, 2006.


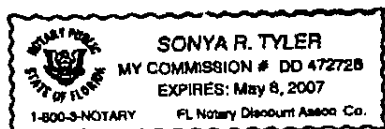
