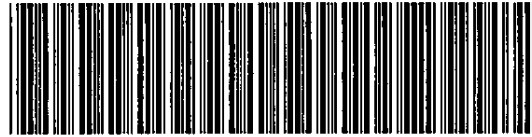


FIRST: The Articles of Organization were filed on 10/30/2006 and assigned document number L06000105236.
