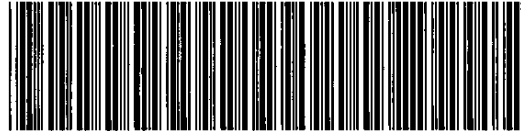

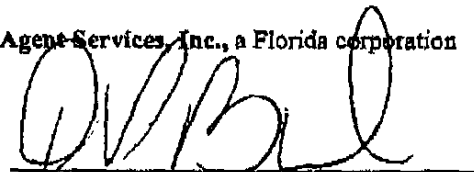
ACCEPTANCE BY APPOINTMENT
