ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of Crystal Imports, LLC, a Florida limited liability company (the "Company"), are hereby amended as follows:

1. The name of the company is Crystal Imports, LLC.
2. The Articles of Organization of the Company were filed on October 30, 2006, and assigned document number L06000105311.
3. The Articles of Organization of the Company are hereby amended to add a new Article 7 to read in its entirety as follows:

"ARTICLE 7
Evidence of Membership Interests

The interests of the Company are securities represented by certificates in registered form governed by Article 8 of the Florida Uniform Commercial Code and shall be treated as securities for all purposes under the Florida Uniform Commercial Code."
