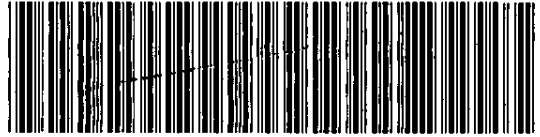

FIRST: The Articles of Organization were filed on October 30, 2006, and assigned Document Number L06000105324.

SECOND: The purpose of this Amendment is to change the name of the Limited Liability Company to: MBN Contracting, LLC as follows:

- (a) The limited liability company's Articles of Organization are hereby amended to reflect a change in the name of the Company to **MBN CONTRACTING, LLC**, by deleting Article I in its entirety from the Articles and substituting in its stead the following new Article I:

“ARTICLE I NAME

The name of the limited liability company shall be: **MBN CONTRACTING, LLC.**

- (b) The Company's Articles of Organization are hereby amended to reflect that the principal place of business and mailing address of the Company shall remain: **12 Miracle Street Parkway, Suite 102, Fort Walton Beach, 32548.** ARTICLE II in the Articles shall read as follows:

THIRD: The Articles of Organization shall be amended to reflect the current members or successors in interest as follows: **Gerald Morris 51%, TJB, LLC. 49%.**
