Name and Address of Registered Agent



The Company shall be a member managed company. The member of the company is Michael J. Greenberg.

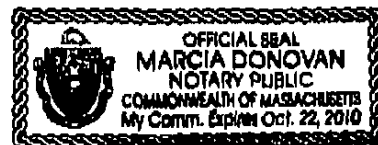


