

**ARTICLES OF ORGANIZATION

The undersigned, desiring to form a Limited Liability Company under and pursuant to §608.405, Florida Statutes, does hereby certify as follows:

FIRST: The name of said limited liability company shall be THOMAS REX INVESTMENTS, LLC

SECOND: THOMAS REX INVESTMENTS, LLC shall exist in perpetuity.

THIRD: Copies of the Operating Agreement of THOMAS REX INVESTMENTS, LLC may be obtained from the Manager at 6020 S.W. 133rd Street, Miami, FL 33156, which is the place in the State of Florida where the principal office of the limited liability company is located.
