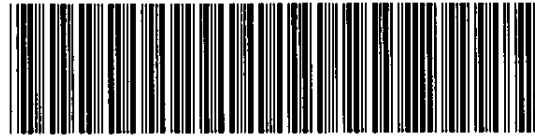

**FIFTH:** The Members will wind up the limited liability company's activities and affairs.


