**ARTICLES OF CORRECTION TO THE
ARTICLES OF ORGANIZATION OF
ROCKY PATEL ENTERTAINMENT, LLC**

I hereby file these Articles of Correction as a duly authorized representative of a member of a limited liability company formed pursuant to the Articles of Organization and the laws of the State of Florida.

The Articles of Organization for ROCKY PATEL ENTERTAINMENT, LLC (the "Company") were filed with the Florida Secretary of State on November 1, 2006 and issued Document Number L06000106480.

1. Article II is incorrect in its designation of the suite number of the principal office and mailing address of the Company. The Articles of Organization of the Company are hereby corrected by deleting in its entirety the present Article II and by substituting therefore the following:
