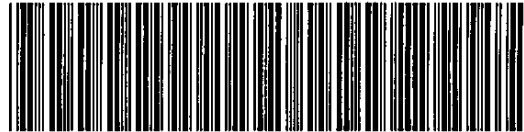

ARTICLES OF ORGANIZATION

The undersigned do hereby subscribe to, acknowledge and file the following Articles of Organization for the purpose of creating a Limited Liability Company under the laws of the State of Florida.

ARTICLE I (Name of Company):




8.2 The Members shall enjoy voting power and authority in proportion to their Interests.
