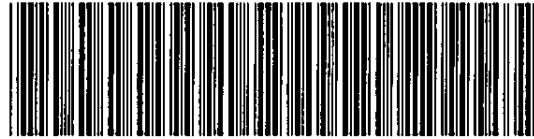

ARTICLE V - PURPOSES


