Additional Members may be admitted upon the approval of a majority of the ownership interest of the Company, upon the

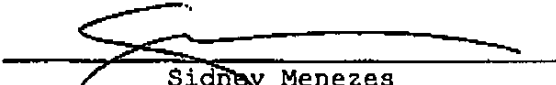
written application of such new Member, in the manner set forth in the Operating Agreement of the Company.
