ARTICLES OF ORGANIZATION
OF
OCTANE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be OCTANE, LLC (the "Company").

ARTICLE II -- ADDRESS

The mailing address of the Company shall be P.O. Box 856, Naples, Florida 34106. The street address of the initial principal office of the Company shall be 3170 S. Horseshoe Drive, Naples, Florida 34104.

ARTICLE III -- DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Company's Operating Agreement.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

ARTICLE V -- MANAGEMENT

The Company shall be a manager-managed company, as that term is used in Section 608.422(3), Florida Statutes, and in accordance with the terms of the operating agreement adopted by the Company's member for the management of the business and affairs of the Company. The operating agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles.
