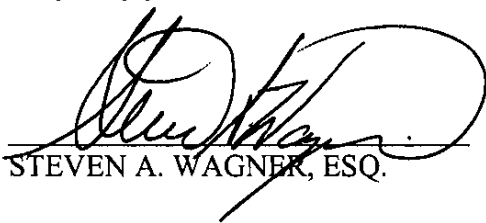

ARTICLES OF ORGANIZATION OF
REYNA HAPPY HOMES, LLC
A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, in forming a Florida Limited Liability Company ("Company") under the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes, hereby adopt the following Articles of Organization for such Company:

ARTICLE I - NAME

The name of the Company is REYNA HAPPY HOMES, LLC.

ARTICLE II - DURATION

The existence of the Company shall commence as of the date these Articles of Organization are filed by the Department of State and shall continue in perpetuity from that date unless earlier dissolved in accordance with the provisions of Article VI herein.

ARTICLE III - ADDRESS

ARTICLE IV - INITIAL REGISTERED AGENT

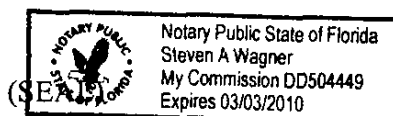
