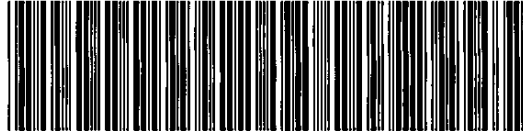

**ARTICLES OF ORGANIZATION  
OF CASA LUNA PARTNERS, LLC**

**ARTICLE I**

The name of the limited liability company is Casa Luna Partners, LLC.

**ARTICLE II**

The period of the limited liability company's duration shall be thirty (30) years from the date of the filing of these Articles of Organization with the Department of State.

**ARTICLE III**

The purpose for which this limited liability company is organized is to operate and manage a restaurant.
