**ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION OF  
LIBERTY VP BRANDON, LLC  
(A Florida Limited Liability Company)**

Pursuant to Section 608.411, Florida Statutes, **LIBERTY VP BRANDON, LLC**, a Florida limited liability company (the "Company"), hereby adopts the following Articles of Amendment:

**FIRST:** The Articles of Organization were filed on November 7, 2006, and assigned document number L06000108259.

**SECOND:** Article I of said Articles of Organization is amended in its entirety to change the name of the Company from "**LIBERTY VP BRANDON, LLC**" to "**LIBERTY VP DAYTONA SPEEDWAY, LLC**", by deleting the provision of said Article I as the same now exists and by substituting in lieu thereof, the following:

**"ARTICLE I - NAME**

The name of this limited liability company is **LIBERTY VP DAYTONA SPEEDWAY, LLC** (the "Company")."

**THIRD:** All other provisions of the Articles of Organization remain unchanged and in full force and effect.

**FOURTH:** The foregoing amendment was adopted by the sole Member of the Company pursuant to approval and execution of that certain Written Consent of Sole Member of even date herewith.
