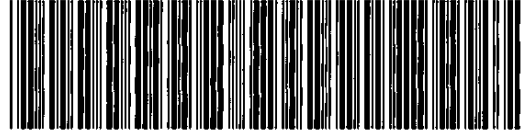

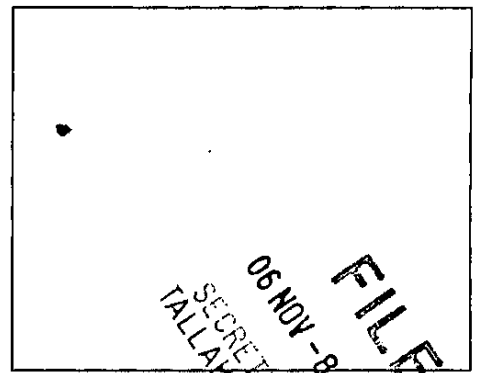

The mailing address and street address of the principal office of the Company is 1441 Brickell Avenue, Four Seasons Tower, 15th Floor, Miami, FL 33131.


