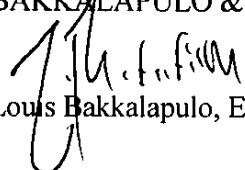

**ARTICLES OF ORGANIZATION**  
**FOR THE PROFESSIONAL LIMITED LIABILITY COMPANY**  
**OF**  
**LIEBLING LAW, LLC**

**ARTICLE I**  
**NAME**

The name of this Company is **LIEBLING LAW, L.L.C.**

**ARTICLE II**  
**COMMENCEMENT DATE AND DURATION**

This Company shall commence on the date of the filing of the Articles of Organization in accordance with the provisions of Section 608.409(3) of the Act. The period of duration for the Company shall be perpetual.

**ARTICLE III**  
**PURPOSES**

This company is created and formed for the purpose of performing professional legal services and services ancillary to the legal profession and any all other lawful businesses authorized for a Company, including the investment of its funds in real estate, mortgages, stocks, bonds, or other investments and ownership of real or personal property necessary for the rendering of its legal services pursuant to Section 608.403 and 621.08 of the Act.

**ARTICLE IV**  
**PLACE OF BUSINESS**

The principal place of business of this Company shall be 35246 U.S. Highway 19 N., #261, Palm Harbor, FL 34684-1931, and such other place or places as may be designated by the members from time to time.

**ARTICLE V**  
**REGISTERED AGENT AND OFFICE**

The initial registered agent for this Company shall be Louis Bakkalapulo, Esq. of the law office of BAKKALAPULO & BOUTZOUKAS, P.A., and the address of the registered agent for service of process shall be 111 N. Belcher Road, Suite 201, Clearwater, Florida 33765.

**ARTICLE VI**  
**MANAGEMENT**

The Company is to be managed by a manager. The initial manager will serve until the first annual meeting of the members. The initial manager is identified as follows:

**ARTICLE VII**  
**ADMISSION OF MEMBERS**

The initial members of this Company shall be set forth in the Operating Agreement and Regulations adopted by the members as set forth therein. Members must be a professional corporation, a professional limited liability company or an individual, each of whom must be licensed to practice law.

**ARTICLE XI**  
**REGULATIONS**

The members are hereby authorized and directed to prepare and adopt an Operating Agreement and Regulations for the governing of the internal affairs of this Company containing such provisions as they consider necessary, reasonable or desirable, except that no provisions of such Operating Agreement and Regulations may conflict with the provisions of these Articles of Organization, unless otherwise permitted herein. The power to adopt, alter, amend or repeal the Operating Agreement and Regulations shall be set forth in the Operating Agreement and Regulations, except that the initial form shall be approved by all the members.

**ARTICLE XII**  
**CONTRACTING DEBTS**

No debt shall be contracted nor liability incurred by or on behalf of this Company except by a vote of a majority in interest of the members.

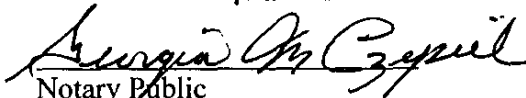

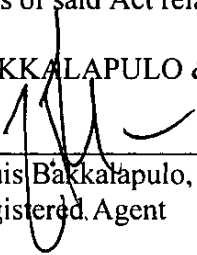
