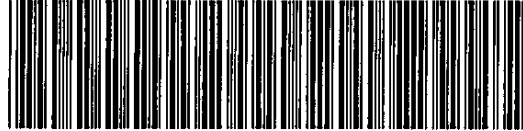

**ARTICLE I - NAME.**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date as specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in the Company's regulations.

#### **ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS.**

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his interest only as set forth in the Company's regulations.

#### **ARTICLE VII - MEMBER'S RIGHT TO CONTINUE BUSINESS.**

The unanimous approval of the remaining members is required to continue the business upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in this limited liability company.

The members of the company shall contribute to the capital of the company by way of cash or property, in accordance with the Company's regulations.


#### **ARTICLE IX – ADDITIONAL CAPITAL CONTRIBUTIONS**
