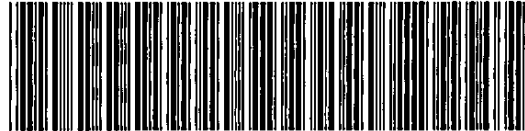



ARTICLE I

NAME:

MANAGEMENT:


