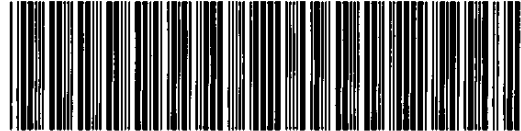

PRINCIPAL OFFICE


