The Company is to be a manager-managed company and the name and address of the initial manager is:

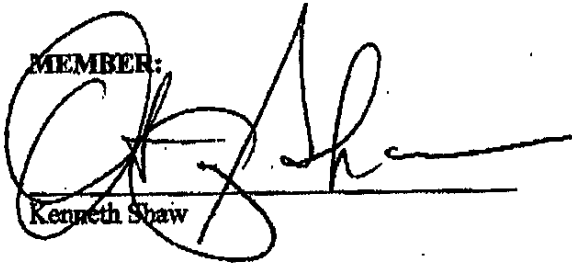

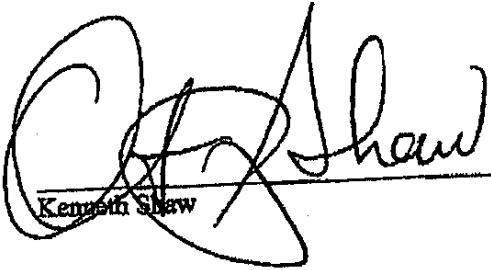
